

WHY ENGAGE IN VENTURE PHILANTHROPY AND SOCIAL INVESTMENT?

NEW MODELS FOR SOCIETAL CHANGE

European societies are looking for new models to tackle social, environmental and cultural challenges, at a time when we are becoming more aware of pressing societal issues and government budgets are increasingly constrained. At the same time, social enterprises and organisations are eager to develop solutions to these challenges. However, they often lack stable funding, organisational capacity, and access to partnerships to become sustainable and work at the scale that is needed today.

To support the development of solutions for today's societal issues and maximise their impact, high engagement and long-term support of social purpose organisations is needed. This support encompasses flexible and tailored funding, organisational support and impact management - it is referred to as Venture Philanthropy or Social Investment.
