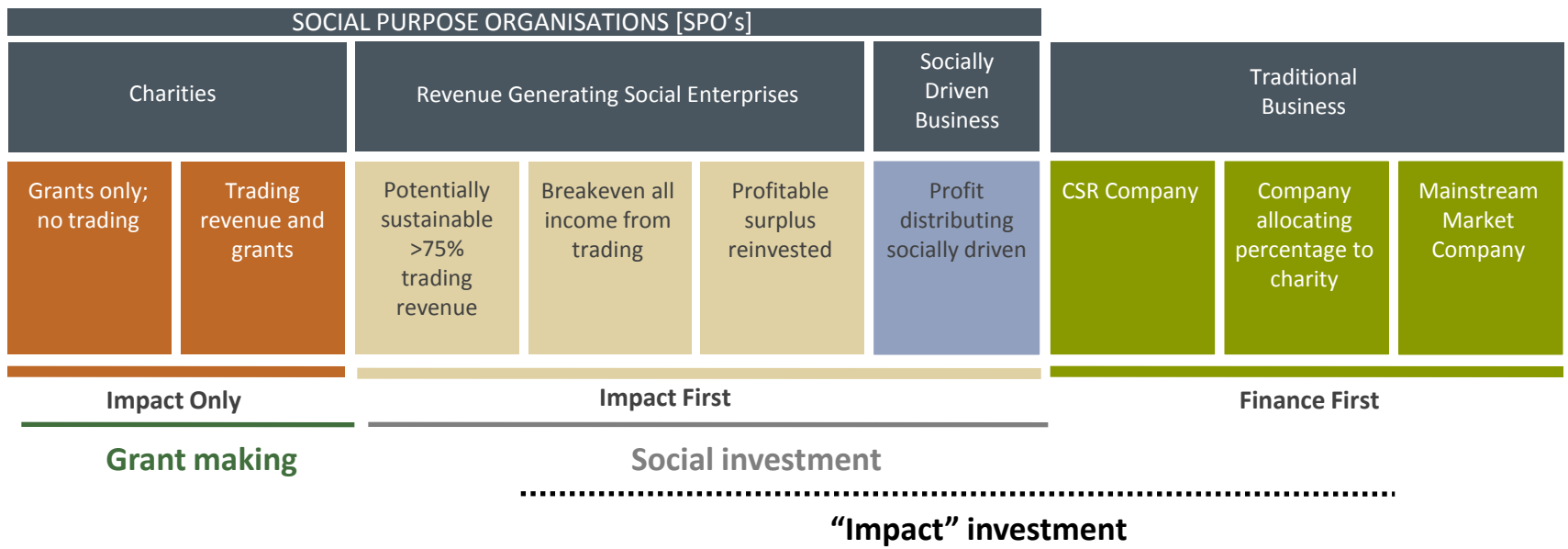

- 130 Members from 20 countries within a wide range of sectors, including social investment, private equity, foundations, advisory firms, academia and private banks

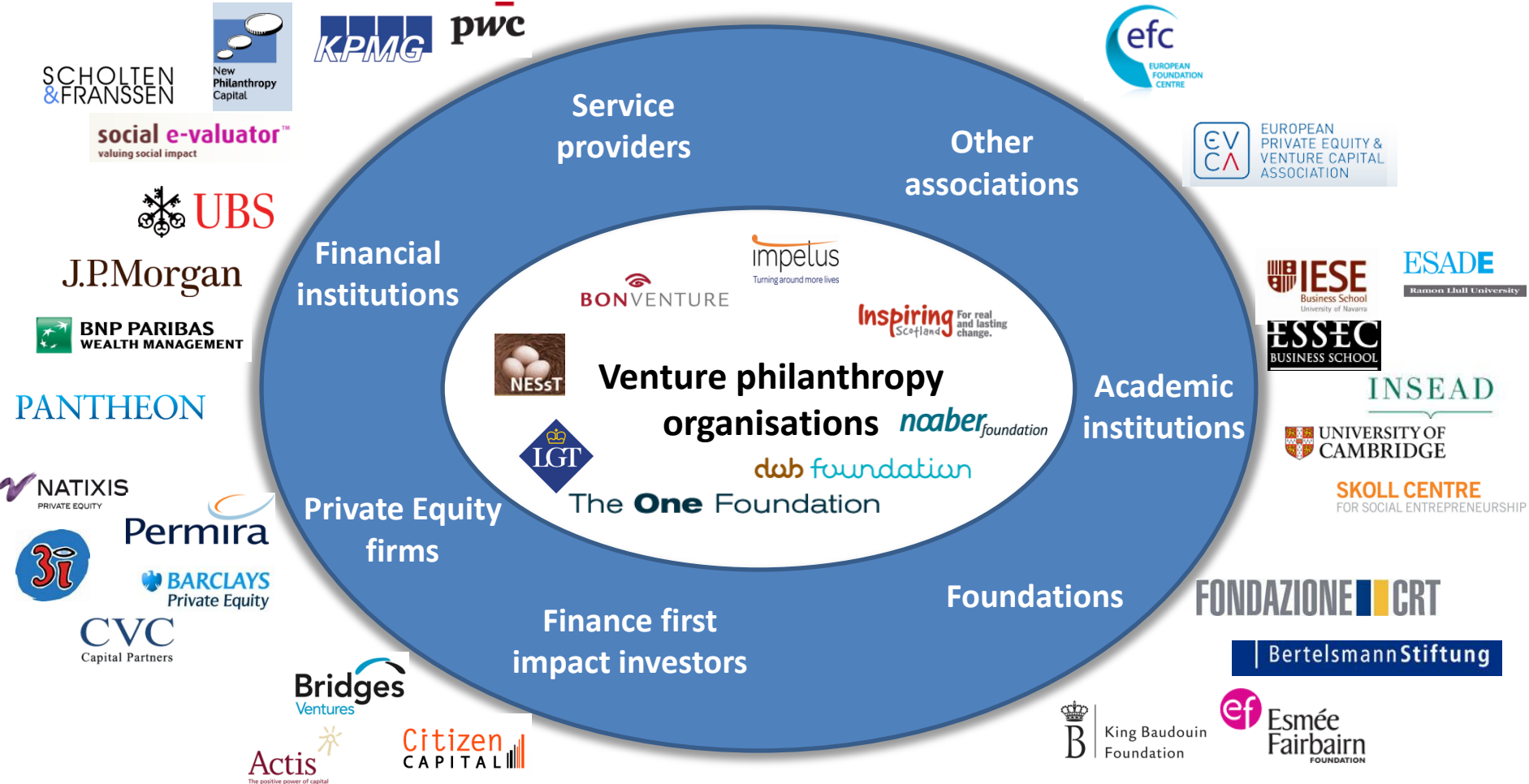
Mission

Full membership

Open to organisations whose **activities include venture philanthropy** and who have set aside a **designated budget for VP activities**

Associate membership

Open to organisations with a **serious interest** in venture philanthropy and a **good standing** within their industry

Honorary membership

Invitation-only by the EVPA Board for individuals or organisations who can provide **valuable insight** and/or **assistance** to EVPA's mission and goals

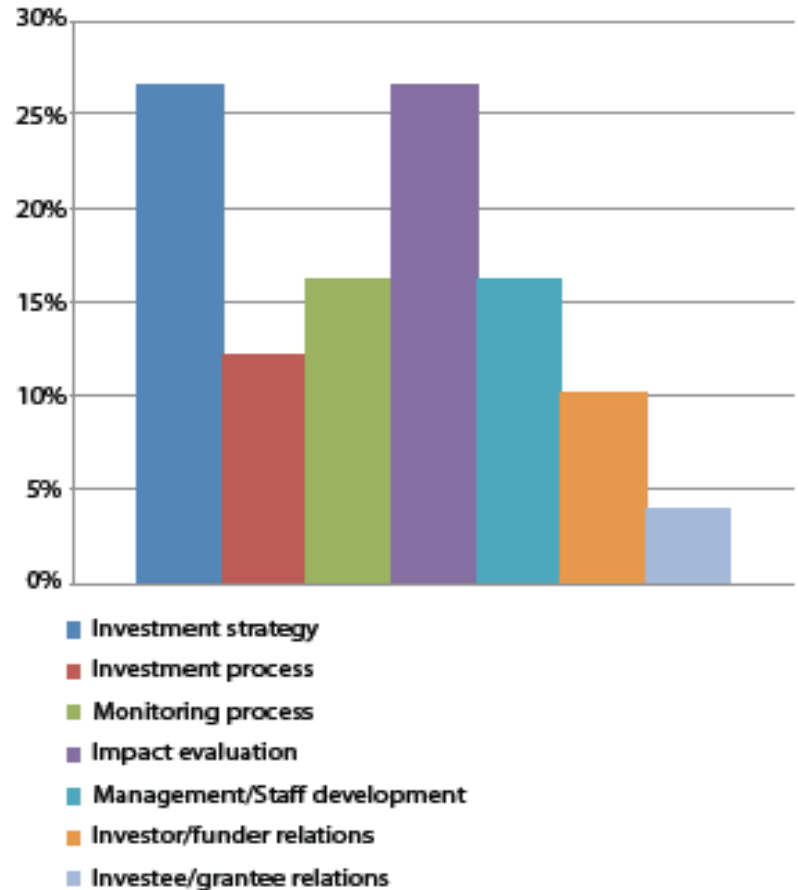
- EVPA Knowledge Centre website has a database of over 200 external publications on the key topics in venture philanthropy
